MOU vs. CESS - The future is bright

October 21, 2009 was the date on which the MOU between LNGG and the Municipal Council of Naivasha was finally signed and a cheque of KES 10 Million handed over. This report contains details of what has happened since then.

The road to a closer working relationship between Naivasha growers and the Municipal Council in Naivasha over service provision, transparency, and progress has finally seen the light. This is the end result of extended and cordial discussions between our Chairman, the Mayor, Town Clerk, and Town Treasurer.

In line with the terms of the MOU, MCN have provided their audited 2008 accounts and a copy of the Council's letter to their lawyers to withdraw the case on Cess. The Council has also opened a new bank account into which the money collected from the MOU is to be deposited. Although growers will not be signatories to the

EIA and Audit - What you need to know

At the recent AGM, members raised the question as to what one does to fulfill their NEMA annual audit requirement. Here is a short guide to how one can be compliant.

When the Environmental Management and Coordination Act (EMCA) was adopted in 1999, all farms already in business were required to conduct an Initial Audit (IA) on the existing farm and any future plans for the farm, and all farms that started after 1999 were required to have an Environmental Impact Assessment (EIA) conducted prior to any changes being done on the land on which the farm was to be situated. This IA or EIA has to be conducted by a professional, registered Lead Auditor.

From either of these assessments, an Environment Management Plan (EMP) would have been developed to help you keep track of your environmental impacts and mitigation plans.

Each year the annual audit is meant to report on how well you have done on your mitigation plans and to assess if there are any other environmental impacts that have arisen as a result of changes in or additions to your production mechanisms.

The EMP should include all aspects of your business, that is, from procurement of inputs to delivery of product and disposal of all wastes. Each aspect requires a home-made policy that is tailored to the company and addresses how the company sees itself in respect to the environment it depends on and its responsibility towards mitigating impacts on the same. There should be a section on wildlife and habitat, and if you your farm borders riparian land (be it the lake or rivers) you should include a section on this separately as required in the LNGG Code of Practice.

For each section on which the company has a policy, you will have a list of environmental impacts resulting from your activities. These impacts can be on the soil, air, fauna, flora, as well as human beings. You can include occupational hazards and safety measures in your EMP to ensure you have covered all aspects of risk and impact.

A register of each impact, with a planned mitigation, timeline and budget will help you audit your annual progress.

Each year, your health and safety committee and environmental committee/advisor can look over this schedule, remove impacts that are now mitigated, and add those that need to be considered in the short, medium—or long-term.

Your annual audit is simply a report on this activity that includes:

- An Introduction, containing a short history of your farm, its location, any particularities, and all activities done on the farm
- A summary of your policies (this should be brief and taken from your EMP)
- The negative impacts of your activities and how they have been mitigated over the year
- The positive impacts of your activities and how they are being fostered
- Any new impacts identified and mitigations planned

The audit report is to be sent to NEMA Headquarters in Nairobi, who request 3 bound copies and one CD. Ensure your EIA or IA reference number, given by NEMA, is clearly printed on the front page of the report.

Please remember that ALL new projects, including water abstraction points, need an EIA, unless it is included in your IA or initial EIA!

LNGG has a sample EMP and audit report and can help you develop your own EMP. We can also assist you with finding a suitable auditor to conduct your IA or EIA..

LNGG Membership - necessary improvements

At our recent AGM, members voted to change a few aspects of membership to LNGG.

Provisional Membership

In the current constitution of the LNGG Provisional Membership (which will be changing to Associate Membership) is similar in definition to Full Membership, except that the former has no voting rights and does not have to adhere to the Code of Practice. This locks the door on having any other support institutions, such as the financial sector, input supply sector and so on from participating in LNGG if they wish. It also means that growers within Naivasha can be provisional members, without

having to adhere to the same rules as other members. Hence, it was agreed that the clause would be changed to read associate membership and that support sectors and growers outside of Naivasha Basin could be included in our membership at a rate of KES 25, 000 per year.

They would be invited to all general meetings but would not be eligible to vote. They would also be allowed to become board members (as is in the current constitution).

Membership Rates for Vegetable Producers

LNGG has differential rates for flower and vegetable producers as a result of the differences in returns. Hence, all vegetable producers are being charged half the rate of flower producers.

Membership rates will be reduced if more growers join LNGG.
Hence, this is a call to all members to bring on board more growers. It will increase our unity and reduce your subscription level!

Disability Resource and Information Centre - Free therapy for children for one day

Four years after LNGG and members sponsored the first United Disabled Persons of Naivasha (UDPN) Half-Marathon the resource centre for which money has since been raised annually, has finally been completed.

It is with great pleasure that we can state that the Disability Resource and Information Centre (DRIC) Naivasha is complete. With an additional KES 4.3 Million grant from the Safaricom Foundation and space from the Government, the KES 6 Million centre proudly stands complete in the compound of Naivasha District Hospital, accessible from Kenyatta Avenue.



The opening ceremony will be held on December 3, 2009 at 1000h with the Retired President as chief guest.

On that day, the center will hold a free clinic for children and it is a request that any employee who has a child/children with disabilities be given some time off to attend this clinic, where they will learn important care and therapy tips.

The center will also hold a **Share a Smile Christmas Party** for children with cerebral palsy and rickets.

Finally, the centre requires new/
